# **Concession on Grounds**

The Capital City Classic Dressage Competition 2019 is sanctioned as a Gold Class C and Bronze competition member of Equestrian Canada, Suite 100, 308 Legget Drive, Ottawa, Ontario K2K 1Y6 and is governed by the rules of EC. (A602.1) Statement of Principle: Equine Canada (EC), the National Federation of Canada, supports adherence to humane treatment of horses/ponies in all competitions under its jurisdiction. EC is committed to upholding the welfare of the horses/ponies, regardless of value, as a primary consideration in all activities. Requiring that horses/ponies be treated with kindness, respect and the compassion that they deserve, and that they never be subjected to mistreatment. Ensuring that owners, trainers and exhibitors or their agents use responsible care in the handling, treatment and transportation of their horses/ponies as well as horses/ponies placed in their care for any purpose; providing for the continuous well-being of horses by encouraging routine inspection and consultation with health care professionals and competition officials to achieve the highest possible standards of nutrition, health, comfort and safety as a matter of standard operating procedure; continuing to support scientific studies on equine health and welfare; Requiring owners, trainers and exhibitors to know and follow their sanctioning organization's rules, and to work within industry regulations in all equestrian competition; reviewing, revising and developing competition rules and regulations that protect the welfare of the horses/ponies. The standard by which conduct, or treatment will be measured is that which a reasonable person, informed and experienced in generally accepted equine training and competition procedures, would determine to be neither cruel, abusive nor inhumane.

### RULES AND REGULATIONS - GOLD

#### **GENERAL RULES**

- 1. Every class offered herein is covered by the rules and specifications of the current rules of EC and will be held and judged in accordance with the EC Rule Book and in particular Section E Dressage 2019. (A602.2) Knowledge of the rules is the responsibility of the competitor. Please direct questions regarding rules and regulations to the Steward. All competitors are advised to check the Equestrian Canada Web site: www.equestrian.ca
- 2. ARTICLE E 4.0 SAFETY HEADGEAR (effective Jan 1, 2014). All athletes, regardless of age or level or competition, must wear properly fitted and fastened approved protective headgear at all times when mounted at any EC-sanctioned Dressage competition at the event location.

**Note**: At the tack check which follows the test, the steward may ask the athlete to dismount so that the helmet may be inspected.

- a. All athletes of any age must wear protective headgear at all times while mounted at the event location.
- b. The penalty for contravening E 4.0. is elimination.
- c. Non-competing athletes who contravene E 4.0. will be instructed to dismount until wearing a properly fitted and fastened helmet.
- 3. Any horse/pony entered in any class at a competition may be selected for equine medication control testing while at the event location. (A602.5)
- 4. All tests will be held in a 20 x 60 ring. Only exception to be if a Para Dressage test is requested requiring a change of ring to 20 x 40.
- 5. Gate at A will remain open at all times for all competitors. (E.7.14.3)
- 6. Callers are allowed in all National tests. Competitors must provide their own callers who must be appropriately dressed. (E.9.1.3)
- 7. The horse/pony's competition number must be worn and visible at all times while on Saanich Fairgrounds property, failure to do so may result in elimination. (E.7.11.2)
- 8. Hors concours entries are not permitted.
- 9. No horse/pony may compete in more than four tests/classes per day, including Freestyles and Young Horse classes. (E.7.11.9)
- 10. Neither Saanich Fairgrounds nor any member of the show committee will be held responsible in any way for damage, injury or loss to persons, horses or property of spectators, owners, trainers, athletes or grooms.
- 11. Dogs must be leashed and under control at all times. Loose dogs will be impounded, and the owners fined \$50.00. Any unruly dogs will be asked to leave the show grounds.
- 12. Entry to Show Grounds is through Gate #6 only.
- 13. Any person staying overnight on the grounds is subject to an overnight fee, regardless if you are staying in an RV, tent, horse trailer, car etc. Camping cost is \$40.00 a night, electricity included. Anyone requiring electricity must prearrange with the Show Manager by email.
- 14. Schooling of horses/ponies may only be done by EC Sport License holders. (E 7.11.12.1)
- 15. Lungeing unmounted or work in hand may only be done by the athlete, owner, coach, groom or Person Responsible. (E 7.11.12.4/7.16.3) Lungeing is permitted in specified areas only. Lungeing is not permitted in the grass field at any time. Mounted lungeing is not permitted. (E.7.11.12.5) Lungeing is only permitted in the indoor ring and only two horses can be lunged at the same time.
- 16. All classes will be scored according to current rules of EC using current penalization rules for errors. (E.9.3.2)
- 17. The Show Office will be open on Friday, July 19, 2019 between 3:00 pm and 6:00 pm. The Show Office will also open each morning 45 minutes before the start of the show.
- 18. Ride times will be posted at 3:00 pm on Friday July 19, 2019, at the Saanich Fairgrounds. You may call 250-744-6378 or check our Web site: vscadora.com on Wednesday July 17, 2019. If you provide an e-mail address, we will e-mail your ride times to you.
- 19. DO NOT arrive at the Show Grounds before 12 noon Friday, July 19, 2019. Anyone arriving before this time must report to the Saanich Fairgrounds Office and pay any stabling or ring use fees directly to them.
- 20. You must present to the Show Secretary the following documentation for each horse/pony in order to obtain a show number: a passport/active horse/pony recording and a valid EC horse/pony license, otherwise a temporary horse/pony registration fee will apply. Foreign owners must sign an affidavit verifying the horse/pony's ownership and licensing.
- 21. This being a Gold competition, no leg boots, bandages, bell boots or leg wraps will be permitted in the competition arena. (E 4.10)
- 22. No cross-entry between Gold and Bronze Shows allowed.

#### **ENTRIES**

- 1. **Entries open Monday, May 20, 2019**. Entries postmarked before this date are subject to a penalty of one day for each day early.
- 2. **Entries must be received by Friday, July 5, 2019 at 5:00 pm** and post marked no later than Tuesday, July 2, 2019. Entries received after closing date are subject to a late fee of \$40.00 and will be limited to the ride times available.
- 3. Please use one entry form for each horse and athlete combination with separate cheques for each individual entry.
- 4. Only completed, legible entries that include all photocopies and a signed, dated waiver will be accepted. Entries not including copies of required membership cards will be subject to a \$25.00 incomplete entry fee.
- 5. All entries must include a **photocopy of a current EC Gold Level Sport License and HCBC membership** for both athlete and horse owner, and proof of payment for **2019 horse/pony license** otherwise the temporary license fee will apply. Foreign competitors must be members of their National Federation.
- 6. Competitors wishing to ride in the Amateur category must include a photocopy of a current EC Sport License showing Amateur status as designated by EC (Amateur box must be ticked, and Date of Birth printed on card). Entries not showing proof of Amateur status will be entered in Open classes NO EXCEPTIONS.
- 7. Entries can be mailed to V/S Cadora, c/o Christina Nash, 6945 Charval Place, Sooke, B.C., V9Z 0M7 or emailed to capitalcityclassic@shaw.ca. No hand-delivered entries will be accepted. If the show is over-subscribed, the postmark/emailed received date will be used to determine one's position on the wait list.
- 8. Corrections on entries and monies owing must be cleared up before entries close or entry will be void.
- 9. Please make cheques payable to Capital City Classic or etransfer to capitalcityclassic@shaw.ca password must be 'dressage'.
- 10. Cheques will be cashed prior to the start of the show and numbers will not be given to competitors who have outstanding show entry fees. When obtaining numbers, competitors are required to pay cash for outstanding amounts (i.e. miscalculations, NSF cheque replacements and fees, missing photocopies, etc). The Show Committee will attempt to contact any competitor who has an outstanding balance prior to the start of the show.
- 11. NSF Cheques are subject to a \$35.00 penalty.
- 12. Cheques dated after July 2, 2019, will not be accepted and the associated entries considered null and void.

- 13. The Show Committee reserves the right to limit, to two, the number of horses/ponies ridden by an athlete (A.805.5), also to limit the number of entries, the number of tests ridden by an athlete, Bronze and Gold combined, (Young Horse classes not to count), and/or refuse any entry, split, cancel or combine and/or adjust classes or awards, govern all conditions of the show, and make decisions upon any matter not covered by current EC rules.
- 14. Entries received prior to the closing date, but after the competition is full, will be put on a waiting list. They will not be subject to late fees if they are accepted into the show. If the competitor does not wish to be on a wait list or does not get into the show, all entry fees will be refunded.
- 15. Before the entry deadline, changes to entries are accepted at the discretion of the entry secretary and subject to a \$25 office fee.
- 16. After the entry deadline **no changes** to classes will be made.
- 17. After the entry deadline, horse/pony and athlete substitutions may only be made in the event of illness or injury with a Veterinarian or Physician certificate, providing that the class, test & athlete category remain the same. These changes are subject to a \$25 office fee. Once a horse/pony or athlete has withdrawn from the show, for any reason, these substitutions can no longer be made. Substitutions must be made at time of withdrawal. A certificate must be presented before 3pm Sunday July 21, 2019. You cannot substitute both the horse and athlete in the same entry.

#### **CLASS RULES**

- 1. Classes may be scheduled at any time on the day listed on the class schedule.
- 2. Ride times may be rescheduled at any time due to scratches, errors, overlapping times, unforeseen conflicts or to facilitate the running of the show.
- 3. **Competitors must check** the scoreboard for updated ride schedules on the morning of each show day. In the case of a discrepancy between the posted day sheets and any other published ride schedule, the day sheet will be considered correct.
- 4. In the event that there are less than four entries in any athlete category (Jr, Am, Open), the Show Committee reserves the right to combine athlete categories within classes, where permitted.
- 5. Ties will be broken by the collective marks. Ties remaining after collective marks will stay tied. (E 9.9.4)

#### **FREESTYLES**

- 1. Freestyle music must be in CD format and athletes must provide 2 copies of the CD to the Show Office before 5 pm Friday.
- 2. The freestyle CD's must be clearly labeled with the athlete's name, competition number and any instructions.
- 3. It is the athlete's responsibility to pick up the CD's from the Show Office prior to the close of the show.
- 4. All freestyles will be classified as Open. Entries may ride a maximum of two consecutive freestyles but may not cross-enter to the Bronze Level freestyle or exceed the maximum number of tests allowable per day as specified by the Show Committee or EC. (E.7.11.9.1)
- 5. To be eligible for freestyles in a Gold Level Competition, any horse/pony/athlete combination must have obtained 60% at the same technical level or higher either at this show, or at an EC Gold or Silver Competition prior to this show. (E 10.6.1)
- 6. The EC freestyle level must correspond to the technical level (or the one above) at which the horse/athlete combination is competing in at this show. e.g.: when riding a Second Level technical test you would be eligible to ride a 1st or 2nd Level freestyle. (E 10.6.3)

### **REFUNDS**

- 1. Prior to the show closing date, all fees will be refunded, less the administration fee.
- 2. After the closing date, class and stabling fees will be refunded with a Veterinarian's or Physician's certificate, administration fees will not be refunded. A certificate must be presented to the entry secretary by July 26, 2019 for any fees to be refunded.

#### **CAMPING**

- 1. Is permitted on the grounds in designated spots at a cost of \$40.00/night.
- 2. No water or sewer hook-up but power can be arranged. Please prearrange with entry secretary.
- 3. No dumping of waste tanks anywhere on the fairgrounds. Washrooms at the end of RCMP barn will be available for use. No access to washrooms at main fairgrounds buildings.

#### **STABLING**

- 1. Stalls are available for rent at the show grounds. The cost is \$65 for the weekend and will be available from noon on Friday July 19, 2019 until 7pm on Sunday July 21, 2019. Overnight stabling is \$45 from 7am one day to 7pm the following day. Day stalls are \$25 and are available from 7am to 7pm the same day, with no overnight.
- 2. There is a clean stall deposit of \$50.00, payable to Capital City Classic, that is to be submitted with your request for stabling or in the case of etransferring funds the cheque can be handed in at the show office when retrieving show package. The cheque will be destroyed once the stall is left stripped and checked by the Stable Manager.
- 3. Any damage to the stall will be the responsibility of the competitor and/or the owner of the horse.
- 4. If entries are not paid in full, the stall will remain closed until cash is paid for the outstanding balance.

Schooling Horses/Ponies are permitted to attend competition grounds for schooling purposes for a fee of \$25.00 a day or \$40.00 for the show. A Bronze Level Entry Form must be completed, and number assigned for all schooling horses/ponies by the entry closing date. Stabling is available at the rates shown on the prize list. All fees including the Bronze administration fee must be paid on the Entry Form complete with a signed Waiver. Drug Testing Fees and DC Levy Fees are not applicable for Schooling Horses. Schooling of horses may only be done by EC Sport License holders (E.7.11.12.1). Handlers/Persons Responsible must have HCBC and provide proof of such. Late Fees are applicable after the Closing Date of July 5, 2019 for all Schooling Horse/Pony Entries. All Handlers/Person(s) Responsible and Schooling Horses/Ponies shall be governed by the current rules of Equine Canada and any additional rules set by the competition.

Trailers must park in the designated Trailer Parking Area Only.

## Gold Level Awards

## Awards will be given out once they are confirmed

Rosettes to 6th place. Rosettes can be picked up with the tests after the class is completed.

When there is only one horse/pony in a class, ribbons shall be awarded in accordance with the following chart of percentages: No ribbons shall be awarded below 4th position.

1st .... 60% or higher 2nd ... 57% to 59.9%

3rd .... 54% to 56.9%

4th .... 51% to 53.9%

Single scores of less than 50% will not count toward any awards, ribbons or prizes. (E 9.9.7)

In the event of a tie, the horse/pony/athlete with the highest total collective marks shall be declared the winner. (E 9.9.4)

If the tie is unbreakable, the horse/pony/athlete shall remain tied. (E.9.9.6)

Champion and Reserve Champions will be established by totaling the two highest percentages of a horse/pony/athlete combination in each division and athlete category. The competitor with the highest total will be named champion. The competitor with the second highest total will be named reserve champion. (E.9.10.4)
